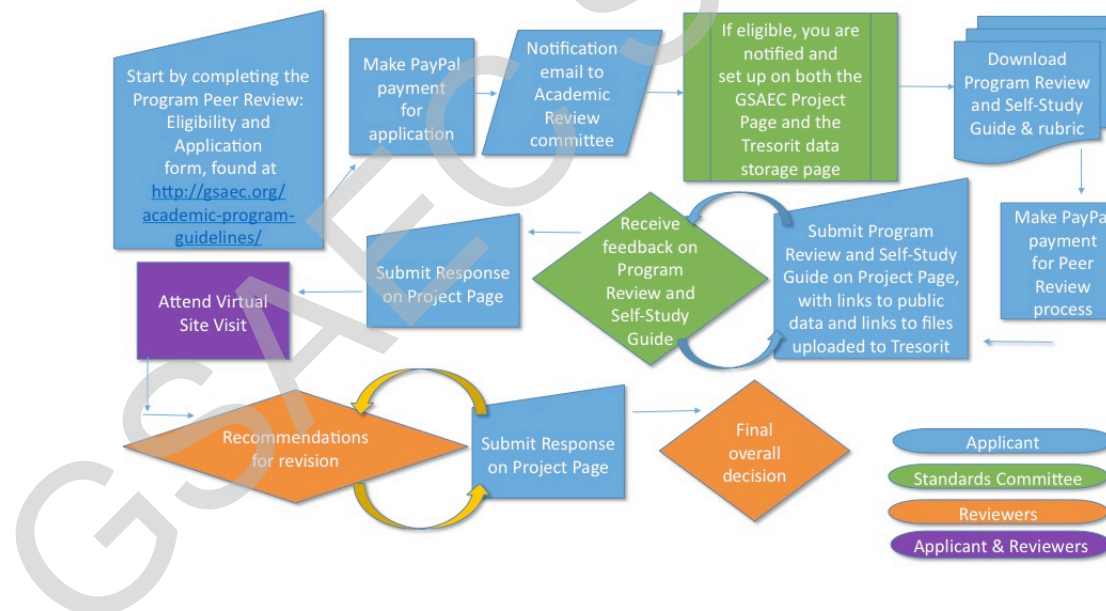
GSAEC ACADEMIC STANDARDS – Program Peer Review Eligibility and Application

INTRODUCTION AND GUIDELINES

The document outline provides an overview of GSAEC’s program peer review process, including the following eligibility requirements below:

- Program(s) must be housed in an accredited graduate institution
- GSAEC institutional member in good standing (USD 1,500 per annum)
- Downloaded and reviewed full GSAEC academic standards document (requires GSAEC membership)
- Peer Review Fee (TBA USD)
